#### **Sound bite of Project Outcomes and Results**

The Minnesota Trappers Association used these funds to complete a site evaluation, master plan, and cost estimate for constructing and outfitting a Sportsmen's Training and Developmental Learning Center located on a 38 acre parcel owned by the Minnesota Forest Zone Trappers Association in Hibbing, MN.

#### **Overall Project Outcome and Results**

The master plan details every aspect of this facility. The main building layout/concept details the indoor exhibit/banquet space that will accommodate 500 people, numerous exhibits, or multiple classrooms as needed. In addition, a commercial kitchen will have the ability and equipment needed to serve a large banquet or daily classrooms in need of nutrition. Further the mechanical, cold storage, retail, office, bathrooms, showers, and janitor space to assure this facility will accomplish the goals of the MFZTA. In addition, the site plan shows how the pond, bog walk, rustic campsites, outdoor classrooms, parking, and RV campsites will all fit. The cost estimates provide the blueprint for the MFZTA to pursue local, state, and Federal grants needed to make this facility a reality. This facility was inspired by a Wisconsin facility that has been successful because the convention is held the same week and month each thus allowing patrons to plan their vacations each year in order to participate in the experience. The MFZTA plans on doing the same.

In addition, the partnerships that are being developed with the Minnesota Deer Hunters Association, Delta Waterfowl, Pheasants Forever, The Grouse Society, Minnesota Darkhouse and Angling Association, Ducks Unlimited, the National Rifle Association, National Wild Turkey Association, and others will promote the longevity and success of this facility. The master plan provides the blueprint that will allow us to teach individuals how the air, water, land, fish, wildlife and other natural resources interact to create the environment as we know it. Improved state policy is the goal.

The site evaluation would include infrastructure (water, sewer, electrical) needs, wetlands, permitting, survey, elevations, cost estimates and soil building conditions. The site would include 24 RV and 24 primitive camp sites, bog walk trails, training facility, educational areas, parking space, equipment/maintenance building, restroom/shower facilities and seating bleachers. Educational activities will include trapping and hunting, environmental/wetlands training, drafting training manuals and providing workshops to designed to get more people involved in outdoor activities; especially youth.
