Sound bite of Project Outcomes and Results

Superior Hiking Trail Association made significant strides in "plumbing the muddy depths" of our trail through improved water management repairs on one mile of tread, 12 reroutes around perennially wet areas ranging from a few 100 feet to 1.5 miles in length, and installing six new stone step crossings.

Overall Project Outcome and Results

Superior Hiking Trail Association (SHTA) is continually challenged to keep water off, and people on, the Trail. Heavy use, deferred maintenance, and poor original design all play a part. Thanks to ENRTF funds SHTA had great success in implementing solutions to address water-causing erosion, which included addressing some of the most pressing deferred water management maintenance along our trail corridor. An instrumental ingredient to our success continues to be the utilization of volunteers. For this project, our match exceeded our original estimate, nearly 3,800 hours contributed by volunteers!

SHTA met all goals initially laid out in the project scope except for a decision to reroute sections of Trail initially planned for recontouring, thus increasing our the number and size of our reroutes, but reducing our water management mileage.

A large focus of the funds were directed towards 12 reroutes, these ranged in length from 100 ft to 1.5 miles. Reroute locations spanned from the Duluth all the way to the Lutsen area. Locations included Knowlton Creek, Brewer Park, Sargent Creek, Kingsbury Creek, Woods Creek, Leskinen Creek, Mystery Mountain, Encampment River, Reservoir Road, Indian Camp Creek, Green Street, and East Haines Road.

The second focus of the funds were stone step crossings, the largest and most prominent project being Encampment River crossing, where 23 small boulders were placed strategically across the riverway with DNR hydrologist design guidance. This crossing has become a focal point along the Trail and it's praised by hikers during the wet months.

SHTA continues to receive praises from our land managers on the outcomes of our work to provide high quality access while actively working to improvement the trail corridor to reduce impacts to the land and water. In the case of these projects, land managers included Lake County, City of Duluth, and Forest Service.

Project Results Use and Dissemination

SHTA highlighted our ENRTF projects as completed through our print materials, website, social media and other media outlets. 2022 project completed were highlighted in our Fall 2022 Ridgeline and upcoming 2023 projects were shared in our Spring 2023 Ridgeline. Each of our RPFs includes recognition of ENTRF. Sign installation took place at some of the large project locations such as Bear reroute, Leskinen reroute and Encampment River reroute/stone step crossing.

Narrative

Project Summary: Bring "plumbing," or serious and effective water management devices and techniques, to the Superior Hiking Trail. This includes building structures and sculpting and managing soil and rock.

Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

Much of the Superior Hiking Trail was not built to modern, national trail building standards. That fact, plus extremely heavy usage of the Trail due to its popularity, coupled with the ravages of climate change, means that water is damaging the Trail by either flowing onto or along it, and not moving off the Trail at all. The result is serious erosion and the proliferation of mud holes. Hikers tend to avoid muddy and wet spots on the Trail; by doing so, they exacerbate the problem by widening the Trail and causing more erosion and creating even more mud.

A lack of "plumbing" on the Trail creates three distinct problems: (1) Increased erosion of the tread into nearby bodies of water, (The SHT follows and crosses nearly 100 named rivers and streams, as well as many lakes and ponds.) (2) A need for expensive fixes, such as boardwalks and reroutes, when erosion and mud holes are left unplumbed for too long, (3) An unsatisfying experience for the tens thousands of annual visitors to the SHT.

The solution to this problem is not technically complicated but it is logistically complex. There's hardly a mile of the SHT that doesn't require what we call "plumbing," or reworking the tread of the Trail. The goal of this plumbing is to make the SHT shed water quickly -- allowing it to move across, not along, the tread -- and to make certain that the SHT, and use of it, is no longer a cause of erosion. Plumbing can be as simple as re-contouring the tread, by cutting back berms that form on the edges of the path or installing dips and drains, to allow water to flow off the Trail. It can mean building simple rock or wooden walkways in perennially wet areas. The solution for each section of the Trail will be determined by the surrounding landscape and how water flows through the area.

Due to the nature of construction projects in the outdoors and the variability of weather in northern Minnesota, we anticipate needing two full trail seasons -- typically June to November -- to complete this project.

As a part our our broader Trail Renewal Program initiative, efforts to plumb the SHT will ensure that every mile of this natural footpath along the North Shore is sustainably built and will be enjoyed by tens of thousands of annual visitors for decades to come -- all without causing unnecessary harm to surrounding lands and waters. With more precipitation expected in the coming years due to climate change, our efforts to make the SHT resilient and well-drained now will pay dividends later to protect and preserve the sensitive habitats and ecosystems through which the Trail passes.

Activities and Milestones

Activity 1: A Resilient Trail By Way of Rebuilt, Reinforced, and Re-plumbed Tread

Activity Budget: \$187,000

Activity Description:

There is no "One Size Fits All" approach to ensuring the SHT sheds water effectively; in fact there are several solutions. We'll employ the right techniques in the right places keep water off the Trail and restore, reshape and rebuild the tread to nationally established sustainable standards.

Our efforts in this activity will include excavating worn sections to establish new contours and installing water management/drainage devices (e.g. drainage dips, swales, ditches) so that water is deflected away from the tread. This will reduce or eliminate erosion and mud holes.

In sections where plumbing is not feasible, we'll make mud holes more resilient and more appealing to trail users by installing stone steps. There is no shortage of native, local stone along the Trail, and well-built stone features have a long useful life expectancy with little maintenance required. And, where needed, we'll build "puncheon" -- simple boardwalk -- to keep trail users from tearing up wet soils and causing erosion.

We will use these techniques, developed by professional trail builders across the country, to make the Trail enjoyable, sustainable, and resilient for years to come.

Overall Update

The budget reflects the final spend down. We received official word in writing from the Department of Labor about the prevailing wage investigation that we ourselves initiated to clarify a sub-contractor project. The DLI notice can be found as an attachment.

The budget spending report now reflects an amendment in the following areas of the budget, salary, contracts, supplies, and final adjusted in match through volunteer hours and final cash match. We ended up using generating more expenses in our supply and contracts line items than initially anticipated, but utilized less staff time than initially anticipated. Our match far exceeds our original. In part this was due to the need to complete the projects with volunteers versus paid contractors to stay within budget of the grant. This is nearly 3,800 hours contributed by volunteers!

We have met all milestones initially laid out in the project scope minus Milestone 6. SHTA was only able to account for approximately 1 mile of recontoured tread. This is in part to the decision to reroute sections of Trail initially planned for recontouring, thus increasing our the number and size of our reroutes, Milestone 5, but reducing Milestone 6.

Overall Update

2023 plumbing projects along the SHT corridor are nearing their start dates. With a late spring, May was not a viable month to start any construction and volunteers and staff focused all their attention to the the heavy windfall of trees, branches and debris that litters the Trail after intense series of winter storms that caused severe damage to the forests along the North Shore. Spring field visits by staff and volunteers to 2021 and 2022 plumbing projects sites have ensured that our hard work and investment have paid off. Newly installed drainage devices and stone steps are holding up well after installation which means we have been successful in our board of reducing harm to the surrounding lands and waters and enter the 2023 trail season ready for heavy flow of new and returning visitors.

While we are on schedule the majority of our grant milestones and goals, we are experiencing challenges in meeting one of the Milestone deliverables - 25 to 50 miles of tread renewed or restored. This goal was incredibly lofty at the start and with the cost of goods and services increasing we will be unable to meet this very ambitious goal.

Overall Update

In 2022 the Superior Hiking Trail Association was able to make some really great strides in "plumbing" the Trail. What is most impressive about the improvement projects is the commitment of our volunteers. The 2022 projects alone clocked over 1,800 volunteer hours and by the close of this grant we will double our anticipated volunteer in-kind hours!

Overall, the slate of plumbing projects are moving along smoothly. The visible impacts on the Trail, particularly due to heavier rainfall in 2022, made our work ever more apparent to our users. The Bean and Bear reroute was one of those highly visible projects and attracted a lot of local attention due to the high number of users who were able to witness the transformation and benefit from the improvement.

Project sites and scopes of work have been confirmed. RPFs for contractors are currently be developed and will posted this week (December 1).

Milestone 4: IN PROGRESS

5 to 10 stone step crossings installed to fix perennial mud holes November 30, 2023

Stone step crossings at Sargent Creek (2021) and Nature Boy Creek (2022) are complete.

An additional five stone step crossings projects are ready for construction in 2023.

Milestone 5: IN PROGRESS

10 to 20 short reroutes (under 1,000 feet each)

Knowlton Reroute, Brewer Reroute, Sargent Reroute, Kingsbury Reroute, Woods Creek Reroute were completed in 2022.

Leskinen Reroute, Mystery Mountain, Encampment are slated for 2023.

Dissemination

Superior Hiking Trail Association has recognized ENTRF in our publications, including the most recent Fall 2022 Ridgeline Newsletter. All RFPs acknowledge ENTRF as the funder of the project and the language used is that identified in the Communications Guidelines set forth both LCCMR. Additionally, an ENTRF sign will be installed along the Bean and Bear Reroute -- a notably 1,600 ft. reroute and a prominent visitor attraction along the trail corridor. The sign has been purchased and will be installed in the spring of 2023.

Overall Update

The juxtaposition of this year's spring thaw/melt and precipitation compared to 2021 is quite telling of the need for better water management on the Trail. More than ever we see the need to improve the "plumbing" of the Trail to keep water off the tread. Progress has been made in 2021 on many elements of the plumbing projects including the milestones listed below. In early 2022 we identified and hiring a contractor for two of the major plumbing projects. One will reroute 1,700 ft. of trail onto higher and drier ground. This reroute alignment has been flagged and construction will begin June 15, 2022. The construction is anticipated to last two weeks and will rely heavily on volunteers. The other major 2022 project will replace end-of-lifespan boardwalk, install stone steps and renew .5-mile section of Trail with water-shedding devices. In addition, SHTA staff spent time conducting field assessments and securing the necessary permits related to another sizeable reroute, 1.5 miles, around a known muddy, wet section of Trail. Staff are devoting time during the 2022 field season to final the project scope and associated planning/permits for 2023 projects to proceed. Overall, we are making great headway.

Activity 1

The following progress was made on milestones 1 through 3:

Milestone #1: 1 of up to 6 stone step crossings was installed

Milestone #2: 3 of up to 20 short reroutes were completed (under 1,000 ft)

Milestone #3: 1 mile of approximately 25 miles of tread were recontoured to shed water

Milestones 4 and 5 were fully completed.

Milestone #4: 2021 trail plumbing projects (3-6 total projects) - (1) Sargent Creek bridge removal (2) Knowlton Creek

Reroute (3) Brewer Reroute

Milestone #5: Identify 2022 project sites, develop scope of work, and hire contractor(s)
