PROJECT TITLE: Bailey Lake Trail and Fishing Pier

I. PROJECT STATEMENT

This project consists of the total reconstruction of the existing Baily Lake Trail and the construction of a new fishing pier on Bailey Lake. The existing trail around Bailey Lake is over 40 years old, is only three to five feet wide in most areas, does not comply with ADA requirements, has cracking asphalt sections with numerous potholes, lacks storm water management which creates erosion problems, one of the bridges needs to be replanked and the trail lacks proper lighting. The existing pier is dilapidated, has been repaired on numerous occasions over the years, does not comply with current ADA requirements and will need to be demolished.

The new trail will be approximately 1.5 miles long, will be a 10 feet wide asphalt trail, decorative lighting will be installed, bridge will be re-planked, signage will be added, culverts and storm water control will be constructed, new fencing will be installed and the area adjacent to the trail will be landscaped.

The new trail will be a public, non-motorized trail and available for walking/hiking/biking traffic. The trail will connect with the Mesabi Trail which allow access to the entire Mesabi Trail system from Grand Rapids to Giants Ridge. The trail will also allow for access to the downtown business district, governmental offices, clinics, dental offices and other city amenities. The trail is located adjacent to a number of senior living facilities including the Rouchleau, Columbia, Alice Nettel Towers and the Laurentian Manor apartments whose residents are regular visitors to the existing trail.

The new fishing pier will be constructed on Bailey Lake and will be able to be accessed by the new trail. The new fishing pier will be located on the north end of Bailey Lake (See Visual) and will be approximately 230 feet long. Bailey Lake is approximately 32 acres and is over 40 feet deep in areas. The lake is habited by a number of species of fish including blue gill, sunfish, bullhead, perch, bass and northern pike. Baily Lake is heavily fished by the residents of Virginia and visitors from surrounding communities.

The completion of the trail and fishing pier will provide outdoor activities, within a city setting, that can be enjoyed by all residents and visitors. These amenities will complement all of the outdoor attractions within the city including the park system, trail system, school playgrounds, picnic areas, ballfields, tennis courts, skating rinks and other fishing locations within the city. The trail will also provide a non-motorized alternative to access a wide variety of locations within the city and will promote active, healthy living.

Project Manager Qualifications

The overall manager for this project will be the City of Virginia under the direction of the Mayor/City Council and City Staff. Additional project management and over-site will come from the consulting engineer. Britt See-Benes (City Administrator), Bill Hennis (City Engineer) and Ed Alto (Park and Rec Director) and the city park committee have been overseeing the development of this project since its initial inception and have many years of experience in overseeing large city construction projects.

Organization Description

The City of Virginia is located in Northeastern Minnesota in the center of St. Louis County's Mesabi Iron Range. Virginia is approximately 65 miles north of Duluth and is included in the Duluth Metropolitan Statistical Area. There are several nearby Iron Range communities all within ten miles, including: Aurora, Biwabik, Buhl, Eveleth, Gilbert, and Mountain Iron. The Minneapolis/St. Paul Metropolitan area is about 200 miles south, or three hours by car.

Virginia is also situated at the southern edge of the massive 3 million acre Superior National Forest, of which, thirty three percent is located in the Boundary Waters Canoe Area Wilderness, and also borders Canada's Quetico Provincial Park. Highways 169 and 53 are major access routes to these popular canoe and recreation areas.

The landscape of Virginia is dominated by the mining history of Minnesota's Iron Range. The City of Virginia is surrounded by several active taconite mining operations. The land was originally covered by Mixed Hardwoods and Pines, along with Aspens. The area is also dotted with conifer bogs and swamps. The landscape in Virginia is rural in nature and most development is adjacent to Highways 169 and 53. The Sturgeon River and Cloquet Valley State Forests are each within 15 miles of Virginia. Both offer numerous activities including canoeing, hiking / biking and off road ATV trails. The Iron Range Off-Highway Vehicle State Recreation Area is also located near Virginia. This is the state's only OHV Park and it offers over 36 miles of trails.
