Project Summary: To slow the spread of invasive emerald ash borer and maintain a robust tree canopy, Edina will create an ash tree removal program focused on low-income and multifamily housing.

Narrative

Emerald ash borer (EAB) came to Hennepin County in 2009 and has done significant damage to Edina's tree canopy. In 2020 the City completed a grant-funded public street tree inventory that identified 2,000 ash trees needing replacement because EAB made them a public safety hazard. The City's NextGen Trees initiative used American Rescue Plan Act funds to plant 1,000 new trees. 250 of those were planted at affordable housing properties and 750 on public lands. However, the City has not had the financial capacity to identify and remove EAB-infested trees on private land. With those one-time ARPA funds exhausted, tackling the likely hundreds of infested trees on private land is cost-prohibitive for both residents and the City. Removing EAB-infested trees can cost thousands of dollars, making it cost-prohibitive for low-income families. This means infested trees remain, furthering the spread of invasive EAB and increasing the risk trees will fall and cause significant harm to a person or to homes, utility lines, and other vital infrastructure. LCCMR funds, however, would allow the City to scale this successful initiative by removing infested and hazardous ash trees, reducing the spread of invasive emerald ash borer, and achieving a robust tree canopy.

With LCCMR funds, the City would establish an EAB removal program for residents, with a specific focus on low-income and multi-family unit housing in Edina. Due to limited staff capacity, the City would contract with a licensed arborist company. This contractor, selected via RFP, would remove trees from private lands. Over two rounds of removals in 2026 and 2027 (outside of EAB flight season, which is May through October), our goal is to have infested ash trees removed from at least 100 Edina properties.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

The program's goal would be to remove EAB-infested ash trees from at least 100 properties. This would make a significant dent in our work to slow and reduce the spread of invasive emerald ash borer in Minnesota. The longer these hazardous trees stay in the ground, the higher the chance they will spread EAB and the more dangerous they become to public safety. This program will protect Edina's ash trees that are not currently infested, allowing our tree canopy to further thrive.

Activities and Milestones

Activity 1: Contractor Tree Removal Work

Activity Budget: \$499,998

Activity Description:

Objective: City will work with a licensed arborist contractor to remove infested ash trees on private lands

- Contractor RFP will be prepared by City staff
- Selected contractor will be made an official City "vendor" with a two-year contract
- Once City connects contractors with residents, contractor will schedule removals with residents
- Contractor will report on each removal to City staff for grant reporting
- Removals will occur outside of EAB flight season, which occurs from May to October

Budget is not marked as \$500,000 because system would not let me input \$0 for Activities 2 and 3. Funding will go to Activity 1 while Activities 2 and 3 will be "in-kind" as part of City staff duties.

Objective & outcome: get at least 100 properties to participate in the program, including low-income and multi-family households

- City staff will engage with residents throughout the grant cycle
- Communications department will market the program through City newsletters, social media, neighborhood associations, and more
- Forestry and Engagement division staffs will do direct outreach at properties near clusters of infested ash trees identified in 2021 public lands inventory
- City staff will table at community events such as the Centennial Lakes Farmers Market, Arbor Day, and the Edina Art Fair

Due to limited staff capacity, the City would not conduct the removals, but would contract with a licensed arborist company. Residents would apply to the program via the City, who will connect them with the contractor. The contractor will schedule with residents, remove infested trees, and invoice the City. The City will apply to other grant opportunities at the local, state, and federal levels to continue the program after the ENTRF grant ends. The hope is also that the pilot is successful enough to make the case to City Council to support its continuation with general fund appropriations.
