Project Summary: The Nature Accessibility Initiative aims to build upon the recent improvements to the Long Lake campus, trail systems and equipment so that people can experience the wonders of nature.

Access to nature is beneficial to people of all ages, races, income groups and abilities. This project would help Long Lake Conservation Center continue its efforts to make trails accessible to people of all abilities. We say we welcome all students and adults but if we do not have the infrastructure for all people to join us on our adventures it is not very welcoming at all. In recent years we have made efforts to increase our accessibility by obtaining adaptive canoeing equipment, adaptive cross country ski equipment and leveling and packing one of our most popular trails that leads to our amazing bog ecosystem. We would like to continue our plans by upgrading our hiking path down to and all the way around Long Lake. Something about the general public using the trails too and that in rural Minnesota accessible nature areas can be difficult.

The Nature Accessibility Initiative will level and finish all trails and paths at Long Lake, including the three-mile lake loop, install safety railings on the bog boardwalk, purchase two rugged, individual track vehicles that would allow for people with mobility issues to reach all corners of nature, and install passive educational signage along the entirety of the trail system and on campus so the general public can learn about the ecosystems they are exploring.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

The outcome is equal access to the wonders of nature, and the educational programming Long Lake offers to 3,000+ students each year. Physical limitations will no longer prevent any visitor to Long Lake from being able to access our incredible bog ecosystem, or share in a lake hike with their classmates.

Activities and Milestones

Activity 1: Bog trail and campus trails completion

Activity Budget: \$52,000

Activity Description:

A portion of the bog trail loop was completed last year. This activity will complete the campus trail, connecting to the bog trail, and complete the unfinished portion of that loop. Additionally, railings will be added to the bog boardwalk, for the safety of people on wheelchairs. A great deal of leveling and rock and root removal will be needed. A weed barrier will be installed and class 5 (or recycled asphalt) will be spread, smoothed and compacted. Small but important trail sections on campus, including the trails from the path to the lake, the path to the orienteering field, and the path to the cooperation games area need to made accessible for every student and visitor to Long Lake.

Activity 2: Complete Lake Loop Trail

Activity Budget: \$151,500

Activity Description:

A nature hike on this three-mile trail is a class itself, but the trails are used for other classes, including survival shelters, wilderness meals and wolf pack. A great deal of leveling and rock and root removal will be needed. A weed barrier will be installed and class 5 (or recycled asphalt) will be spread, smoothed and compacted.

Activity 3: Directional and Passive Educational Signage Installed

Activity Budget: \$7,500

Activity Description:

The directional signage will help non-school and public visitors to explore Long Lake's ecosystems more easily. The passive educational signage will add to the experience of students and visitors alike. These signs will highlight and explain elements in nature, such as basic bog ecology, unique plants, etc.

The project will be implemented based on highest usage. The trail from the campus to the bog trail will be completed first, followed by the second half of the bog loop (the first half was completed last summer), and the railings will be installed on the bog boardwalk. After this, the lake trail will be completed. Signage will installed throughout the project. After completion of the Initiative, trails will be repaired and maintained by the Aitkin County Land Department and Long Lake, out of operating costs.
